## DEPARTMENT OF CHILD SAFETY MONTHLY STAFFING REPORT AUGUST 2014

Pursuant to Laws 2014, Chapter 4, the Department of Child Safety developed a monthly report on the Department's progress in hiring child safety staff. Staffing numbers captured in this report reflect information as of the final day of the month. Due to delays in processing, final numbers may be different in subsequent reports.

In FY 2014 supplemental appropriations and in the FY 2015 budget, the Legislature and Governor approved the addition of 212 new caseworkers and 120 supporting positions (supervisors, case aides and support staff). These additional 212 caseworkers brought the total number of authorized Specialist positions to 1,406. At the end of January, the Department had 1,190 filled Specialist positions (caseworkers and intake staff) and 130 unfilled Specialist positions. As of August 30, the Department had 1,278 filled Specialist positions. Due to inevitable delays in processing and capturing personnel data, the Specialist numbers in July have been adjusted to reflect the actual filled position numbers. With the additional positions added in FY 2015, there are currently 128 unfilled positions. Hiring details for the Specialist positions are shown in *Table 1*.

The Department has 53 positions for which offers have been accepted and staff are scheduled to begin in September. The Department will continue its hiring efforts to keep up with attrition as well as to continue filling the additional positions authorized for FY 2015.

The Department is continuing to recruit and hire the 120 non-caseworker positions. All of the Assistant Program Managers and all but two Unit Supervisors have been hired. Interviews have been completed for many of the support staff positions and 54 of the positions have been hired.
