1. Safety Assessment

A DCS representative will provide information pending modifications on the safety assessment specifically as it relates to the present danger analysis. The Committee will discuss and provide feedback regarding the implications of such pending modification in the areas represented by the various committee members. The Committee will discuss and provide feedback regarding ways they may be able to support the implementation of the changing tool.

2. Guardianship as a Permanency Option

A DCS representative will provide on the newly developed Practice Guidelines entitled Guardianship as a Permanency Option. Then the Committee will discuss and provide feedback on ideas for outreach and education on the topic as well as provide feedback on how the prospect of Guardianship as a permanency option may impact families served by the areas represented by the committee members.

3. Parenting Children with Trauma

Emily Jenkins will discuss the project sponsored by Arizona Council of Human Service Providers, who collaborated with Dr. Bruce Perry and DCS, which involves parenting children with trauma, specifically catered toward assisting foster parents, kinship parents, and adoptive parents. The committee will provide feedback.

4. Staff Retention

A DCS representative will provide an update on staff retention. The Committee may provide feedback based on the information.
