Date of fatality or near fatality: 5/14/2011

Child's name: Anays Carimbocas

Age at time of incident: 5 years old

Alleged perpetrator(s) name and age:

Jose Luis Gonzalez-Dominguez – 21 years old at time of incident.

Crystal Carimbocas – age 26 years old at time of incident.

City, town or general location of residence of the child and alleged perpetrator(s):

Mesa, AZ

Circumstances of the fatality or near fatality that indicate it was the result of abuse or neglect:

On May 14, 2011, Anays Carimbocas had difficulty breathing. 911 was contacted and Anays was transported to Cardon Children's Hospital. At the hospital, Anays had no heartbeat and was pronounced dead.

On August 13, 2014, Crystal Carimbocas was found guilty of first degree murder and two counts child abuse in the death of her daughter.

On August 14, 2014, Jose Luis Gonzalez-Dominguez was found guilty of first degree murder and five counts of child abuse in the death of Anays Carimbocas.

Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child and the current alleged abusive or neglectful parent, guardian or custodian*:

CPS received one prior CPS report on September 14, 2010, alleging abuse of Anays Carimbocas by Jose L. Gonzalez-Dominguez and Crystal Carimbocas. Anays was taken to the hospital with both eyes bruised and swelling surrounding the cheek bone area. She also had broken blood vessels on her left ear. CPS and Mesa Police Department interviewed the children and caretakers. It was determined the injuries were accidental, the report was unsubstantiated. New information received in 2011 determined that the injury was the result of physical abuse and the report was substantiated against Jose Gonzalez-Dominguez.

1. Actions taken by DCS in response to the fatality or near fatality of the child including:

CPS conducted a joint investigation with the Mesa Police Department.

2. Actions taken regarding the child and/or other children in the home:

An assessment of child safety was completed for the other children and they were placed in licensed foster homes.



3. Whether the agency is or intends to provide direct services or service referrals to the family:

The family was offered services during the time the case was open.
