**7. Circumstances of the fatality that indicate it was the result of abuse or neglect:**

On February 19, 2017 the Department of Child Safety received a report regarding Willow Brewer, 6 months old, being taken to a local hospital with cardiac arrest and not being able to be resuscitated. Kylie Brewer, Jon Bogdanowich Jr., Kaylie Gossett and Brianna Raidy, were all charged with first degree murder in connection to the death of Willow Brewer.

**8. Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child or the current alleged perpetrator(s)\*\*:**

DCS has received no prior reports involving Willow Brewer.

DCS has received no prior reports involving Kylie Brewer, Jon Bogdanowich Jr, Kaylie Gossett, or Brianna Raidy as perpetrators.

**9. Actions taken by DCS in response to the fatality:**

A joint investigation is being conducted with the Pima County Sheriff's Office.

**10. Actions taken regarding the child and/or other children in the home:**

There were no other children in the home.

**11. Whether the agency is or intends to provide direct services or service referrals to the family:**

No services are being provided at this time.
