**7. Circumstances of the fatality that indicate it was the result of abuse or neglect:**

On June 28, 2020, the Department of Child Safety received a report regarding Meadin Meles-Hebtom and Arsema Kidane who had both been found deceased in their home. On July 2, 2020, Mulue Yamane was charged with first degree murder for the deaths. On February 8, 2023, the Department substantiated the allegations of abuse.

**8. Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child or the current alleged perpetrator(s)\*\*:**

DCS received no prior reports involving the children or Mr. Yamane.

**9. Actions taken by DCS in response to the fatality:**

A joint investigation was conducted with the Phoenix Police Department.

**10. Actions taken regarding the child and/or other children in the home:**

There were no other children in the home.

**11. Whether the agency is or intends to provide direct services or service referrals to the family:**

No services were provided by the Department.
