**7. Circumstances of the near fatality that indicate it was the result of abuse or neglect:**

On February 6, 2020, the Department of Child Safety received a report regarding twin 2-month-old females who had been transported to the hospital with life threatening injuries consistent with non-accidental trauma. The children had been in the care of their father, Dontae Lavvone Johnson, when they were injured. Eventually, Dontae Lavvone Johnson admitted to shaking the twins on several occasions causing the injuries. He was arrested on March 9, 2020, and charged with multiple counts of child abuse. A dependency petition was filed on February 11, 2020, with the Maricopa County Superior Court regarding the twins and their siblings. On March 12, 2020, a petition for termination of parental rights was filed with the Maricopa County Superior Court regarding the twins and their siblings.

**8. Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child or the current alleged perpetrator(s)\*\*:**

DCS received the following prior report involving Dontae Lavvone Johnson and the child's mother:

On December 15, 2018, a report was received alleging neglect to children by their mother and Dontae Lavvone Johnson. The report was closed and the allegations were substantiated.

**9. Actions taken by DCS in response to the near fatality:**

A joint investigation was conducted with the Phoenix Police Department.

**10. Actions taken regarding the child and/or other children in the home:**

Following an assessment of child safety, the other children in the home were placed in licensed foster care. Upon release from the hospital, the near fatality victim was placed in licensed foster care with her twin.

**11. Whether the agency is or intends to provide direct services or service referrals to the family:**

The Department is providing supportive services to the children and will continue to assess for other services to be provided to the family.
