4. Date of determination that the near fatality was the result of abuse or neglect\*:

- 6. Alleged perpetrator(s) name, age and city, town or general location:

Jurnee Hornbeak – age 19 – Parker, AZ Jacob Moore – age 20 – Parker, AZ

7. Circumstances of the near fatality that indicate it was the result of abuse or neglect:

On March 10, 2015, the Department of Child Safety received a report regarding a 9-month-old victim of a near fatality. The baby had been taken to the hospital where she was found to have sustained extensive and intense physical abuse that was potentially lethal. The child's mother, Jurnee Hornbeak, has been charged with child abuse. It was also determined that the child's father, Jacob Moore, neglected the child by failing to protect her from abuse.

8. Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child or the current alleged perpetrator(s)\*\*:

DCS has received one prior report involving Jurnee Hornbeak, Jacob Moore and the child:

On July 31, 2014, a report was received regarding concerns about Jurnee Hornbeak and Jacob Moore's attitude and demeanor toward the child. They were observed in a public place to become frustrated with the child and neglectful of her needs. The report was investigated and insufficient evidence was found to support the allegations. The report was unsubstantiated and the case was closed on August 19, 2014.

9. Actions taken by DCS in response to the near fatality:

The Department of Child Safety is conducting a joint investigation with the Parker Police Department.

10. Actions taken regarding the child and/or other children in the home:

Following an assessment of child safety, Naomi was released from the hospital and placed in a licensed foster home. There were no other children in the home.
