## 7. Circumstances of the near fatality that indicate it was the result of abuse or neglect:

On July 28, 2023, the Department of Child Safety received a report regarding neglect to a two-year-old male and their siblings. The children were transported to the hospital for evaluations and upon evaluation, it was determined that the child was in serious condition and was diagnosed with severe malnutrition and refeeding syndrome. On August 11, 2023, a dependency petition was filed with the Maricopa County Superior Court. On September 18, 2023, the court found that the parents, Janiece Brooks and Tremaure Stanley, neglected the near fatality victim and their siblings.

8. Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child or the current alleged perpetrator(s)\*\*:

DCS received the following prior report involving Janiece Brooks and Tremaure Stanley:

On July 28, 2023, the Department of Child Safety received a report alleging neglect to a child by their parents, Janiece Brooks and Tremaure Stanley. An investigation was initiated and still in progress when the near fatality report was received.

9. Actions taken by DCS in response to the near fatality:

A joint investigation is being conducted with the Phoenix Police Department.

10. Actions taken regarding the child and/or other children in the home:

Following an assessment of child safety, the near fatality victim and his siblings were removed and placed in foster care.

## 11. Whether the agency is or intends to provide direct services or service referrals to the family:

The Department is providing services to the family.
