Albert Guillen – age 28 – Phoenix, AZ Arabella Finnigan – age 23 – Phoenix, AZ

7. Circumstances of the near fatality that indicate it was the result of abuse or neglect:

On October 19, 2023, the Department of Child Safety received a report regarding a 1-month-old female whose parents transported her to the hospital. Upon examination, the child was determined to be in critical condition and experiencing seizures. Multiple injuries were found, including fractures and brain bleeds, which indicated non-accidental trauma. On October 24, 2023, the Department filed a dependency petition with the Maricopa County Superior Court. On December 5, 2023, the court found the child dependent as to her parents, Arabella Finnigan and Albert Guillen, due to abuse and/or neglect.

8. Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child or the current alleged perpetrator(s)**:

There are no prior DCS reports involving Arabella Finnigan as an alleged perpetrator.

DCS received the following prior report involving Albert Guillen and the near fatality victim:

On September 29, 2023, the Department of Child Safety received a report alleging physical abuse to the child by her father, Albert Guillen. An investigation was initiated and was still in progress when the near fatality incident occurred.

9. Actions taken by DCS in response to the near fatality:

A joint investigation was conducted with the Phoenix Police Department.

10. Actions taken regarding the child and/or other children in the home:

There were no other children in the home.
