**1. Victim:** Michelle Thresher – 4-year-old female

**2. Was the child residing in the child's home or in an out-of-home placement at the time of the fatality?**

The child was residing in her home when the following incident occurred:

On September 18, 2019, the Department of Child Safety received a report regarding 4-year-old Michelle Thresher who became unresponsive at home. Michelle was transported to the hospital where she was pronounced deceased. The Department took custody of the child's siblings and filed a dependency petition with the Maricopa County Juvenile Court on September 23, 2019. On November 4, 2019, it was determined through that proceeding that the child's mother, Allie Harris, neglected her by failing to provide appropriate supervision. The Maricopa County Medical Examiner's report completed on November 25, 2019, stated the death was caused by fentanyl toxicity. **Michelle was in the care of her mother's significant other, Christopher Daniel, when the incident occurred. The Department of Child Safety substantiated the allegation of neglect by Christopher Daniel for failing to provide supervision when the child had access to fentanyl.**

**3. If the victim in the Preliminary Report involved a child residing in the child's home, the following information will be provided:**

**a. Services being provided to the child, a member of the child's family or the person suspected of the abuse or neglect at the time of the incident and the date of the last contact before the incident between the entity providing services and the person receiving services:**

No services were being provided to the family by the Department of Child Safety at the time of the incident.

**b. Was the child, a member of the child's family or the person suspected of the abuse or neglect the subject of a report for investigation at the time of the incident?**

**c. All involvement of the child's parents and of the person suspected of the abuse or neglect in a situation for which a report for investigation was made or in services provided pursuant to this chapter in the five years preceding the incident:**

**Christopher Daniel was involved in the following report in the five years preceding the incident:**

**On November 18, 2015, a report was received alleging neglect to a child by the child's father, Christopher Daniel. The allegation was unsubstantiated. The Department provided information on community resources to the family and the case was closed.**

The child's parents were involved in the following reports in the five years preceding the incident:



On November 9, 2016, a report was received alleging neglect to Michelle Thresher and a sibling by their mother, Allie Harris. The allegations were unsubstantiated and the family completed in-home services provided by the Department.

On July 24, 2017, a report was received alleging neglect to Michelle Thresher's half-sibling by her father and that child's mother. The Department offered services to the father and the report was substantiated.

**d. Any investigation pursuant to a report for investigation concerning the child, a member of the child's family or the person suspected of the abuse or neglect or services provided to the child or the child's family since the date of the incident involving the fatality:**

The investigation of the fatality report resulted in the removal of the victim's siblings from the home. The Department filed a dependency petition with the Maricopa County Juvenile Court and services are being provided to the family. One of the siblings was later assessed as safe in the care of their other parent. No subsequent reports of abuse or neglect have been received.

**4. If the victim in the Preliminary Report involved a child residing in an out-of-home placement, the following information will be provided:**

**5. Actions taken by the Department in response to the case including any changes to policy or practice and/or recommendations for further changes in policies, practices, rules or statutes:**

The Department conducted a joint investigation with the Glendale Police Department. Following an assessment of child safety, the victim's siblings were removed and placed in foster care. A dependency petition was filed with the Maricopa County Juvenile Court and services are being provided. One of the siblings was later assessed as safe in the care of their other parent. No subsequent reports have been received.

Additionally, in accordance with the DCS Strategic Plan for State Fiscal Year 2016 (FY16), multidisciplinary team (MDT) reviews of fatality and near fatality cases were implemented during the first quarter of FY16. The MDT reviews of fatality and near fatality cases, especially those with prior DCS involvement, are a key feature of the Strategic Plan and support the objective of increasing the accuracy of safety and risk assessments in investigations.
