1. **Victim:** Andreana Cardiel – 1-year-old female

2. **Was the child residing in the child's home or in an out-of-home placement at the time of the fatality?**

The child was residing in her home when the following incident occurred:

On June 14, 2017, the Department of Child Safety received a report regarding the 11/24/16 death of 1-year-old Andreana Cardiel. The child was at home when she reportedly stopped breathing. She was transported to the hospital and pronounced deceased. An autopsy was performed and found her to be positive for methadone. The Medical Examiner's report completed on 8/25/17 listed the cause of death as methadone toxicity. The allegation of neglect pertaining to the child's mother, Tammy Galvan, was substantiated by the Department.

3. **If the victim in the Preliminary Report involved a child residing in the child's home, the following information will be provided:**

a. Services being provided to the child, a member of the child's family or the person suspected of the abuse or neglect at the time of the incident and the date of the last contact before the incident between the entity providing services and the person receiving services:

No services were being provided to the family by the Department of Child Safety at the time of the incident.

b. Was the child, a member of the child's family or the person suspected of the abuse or neglect the subject of a report for investigation at the time of the incident?

The child's parents were involved in the following reports:

On April 21, 2013, a report was received alleging neglect to Andreana's half-siblings by Tammy Galvan. The allegations were substantiated and the case was closed after the Department provided services.

On September 10, 2015, a report was received alleging neglect to Andreana Cardiel by her mother, Tammy Galvan. The family successfully completed services provided by the Department and the allegation was unsubstantiated. The case was closed on April 27, 2016.

On September 6, 2016, a report was received alleging physical abuse by Andreana's father to a half-sibling. The allegation was unsubstantiated and the case was closed on September 22, 2016.

d. Any investigation pursuant to a report for investigation concerning the child, a member of the child's family or the person suspected of the abuse or neglect or services



provided to the child or the child's family since the date of the incident involving the fatality:

The report regarding the fatality was investigated and the Department substantiated the allegations of abuse and neglect pertaining to Tammy Galvan. The other children in the home were initially removed, but later assessed as safe with the other parent. The Department provided services to support the family. No subsequent reports of abuse or neglect have been received.

5. Actions taken by the Department in response to the case including any changes to policy or practice and/or recommendations for further changes in policies, practices, rules or statutes:

The Department conducted a joint investigation with the Surprise Police Department. The allegations of abuse and neglect pertaining to Tammy Galvan were substantiated. The other children in the home were initially removed, but later assessed as safe with the other parent. The Department provided services to support the family.

Additionally, in accordance with the DCS Strategic Plan for State Fiscal Year 2016 (FY16), multidisciplinary team (MDT) reviews of fatality and near fatality cases were implemented during the first quarter of FY16. The MDT reviews of fatality and near fatality cases, especially those with prior DCS involvement, are a key feature of the Strategic Plan and support the objective of increasing the accuracy of safety and risk assessments in investigations.

Cases are reviewed by the MDT in order to identify any systemic factors, both internal and external to the Department that may have had an impact. The Department uses the aggregate data gathered through all of the MDT reviews to assess and guide future changes and/or recommendations to policies, practices, rules or statutes. Findings from these reviews are compiled into an annual report to be shared on the DCS website. The target date for release of the next report is December 1, 2018.
