Summary Report Fatality 06/14/2022

Amendments to the information originally posted on 11/04/2021 are displayed below in red.

1. Victim: Dominic Aleff- 7-month-old male

2. Was the child residing in the child's home or in an out-of-home placement at the time of the fatality?

The child was residing in his home when the following incident occurred:

On January 10, 2020, the Department of Child Safety received a report regarding a 7-month-old male, Dominic Aleff, found unresponsive at home. Dominic was transported to the hospital, where he was pronounced deceased. An autopsy was conducted and it was determined Dominic had high levels of fentanyl in his system, along with other substances. Dominic was in the care of his mother, Erika Wahab, and her significant other, Sean Constantino, when Dominic was found unresponsive. On October 26, 2021, the Department substantiated neglect and physical abuse allegations against Sean Constantino. On March 2, 2022, the mother, Erika Wahab, was arrested for one count of 2nd degree murder and one count of child abuse.

- 3. If the victim in the Preliminary Report involved a child residing in the child's home, the following information will be provided:
 - a. Services being provided to the child, a member of the child's family or the person suspected of the abuse or neglect at the time of the incident and the date of the last contact before the incident between the entity providing services and the person receiving services:

There were no services being provided to the family by the Department of Child Safety at the time of the incident.

b. Was the child, a member of the child's family or the person suspected of the abuse or neglect the subject of a report for investigation at the time of the incident?

c. All involvement of the child's parents and of the person suspected of the abuse or neglect in a situation for which a report for investigation was made or in services provided pursuant to this chapter in the five years preceding the incident:

There have been no prior reports involving Sean Constantino.

DCS received the following prior reports involving Dominic Aleff and his parents:

On October 12, 2015, a report was received alleging neglect to a child by her mother, Erika Wahab, and her father. The child was removed and taken into DCS custody on October 15, 2015. Ultimately, the parent's rights to the child were terminated on May 31, 2017. The allegations were substantiated and the case was closed on September 15, 2017.

On May 17, 2019, a report was received alleging neglect to Dominic Aleff by his mother, Erika Wahab. The allegation was unsubstantiated. The family was provided with in-home services which they successfully completed and the case was closed October 29, 2019.

d. Any investigation pursuant to a report for investigation concerning the child, a member of the child's family or the person suspected of the abuse or neglect or services provided to the child or the child's family since the date of the incident involving the fatality:

The report regarding the fatality was investigated and the case was closed on July 8, 2021. The allegations of neglect and physical abuse to Dominic Aleff by Sean Constantino were substantiated. On March 2, 2022, the mother, Erika Wahab, was arrested for one count of 2nd degree murder and one count of child abuse.

A subsequent report alleging neglect to a newborn sibling was received on July 13, 2021. The investigation resulted in the sibling coming into DCS custody. The dependency matter is still ongoing. Services are being provided to the family.

5. Actions taken by the Department in response to the case including any changes to policy or practice and/or recommendations for further changes in policies, practices, rules or statutes:

The Department conducted a joint investigation with the Pinal County Sheriff's Office. There were no other children in the home at the time of the fatality and the case was closed on July 8, 2021. The allegations of neglect and physical abuse to Dominic Aleff by Sean Constantino were substantiated. On March 2, 2022, the mother, Erika Wahab, was arrested for one count of 2nd degree murder and one count of child abuse.

A subsequent report was investigated and resulted in a newborn sibling being placed in out-of-home care. The Department is providing services to the family.

Additionally, in accordance with the DCS Strategic Plan for State Fiscal Year 2016 (FY16), multidisciplinary team (MDT) reviews of fatality and near fatality cases were implemented during the first quarter of FY16. The MDT reviews of fatality and near fatality cases, especially those with prior DCS involvement, are a key feature of the Strategic Plan and support the objective of increasing the accuracy of safety and risk assessments in investigations.

Cases are reviewed by the MDT in order to identify any systemic factors, both internal and external to the Department that may have had an impact. The Department uses the aggregate data gathered through all of the MDT reviews to assess and guide future changes and/or recommendations to policies, practices, rules or statutes. Findings from these reviews are compiled into an annual report to be shared on the DCS website. The target date for release of the next report is December 1, 2021.
