- **1. Victim:** Emmanuel Bear-Hawk Diaz newborn male
- 2. Was the child residing in the child's home or in an out-of-home placement at the time of the fatality?

The child was residing in his home when the following incident occurred:

On November 28, 2022, the Department of Child Safety received a report regarding the home birth of Emmanuel Diaz, who was unresponsive after birth. The child was transported to the hospital and pronounced deceased shortly after arrival. The Maricopa County Medical Examiner concluded that methamphetamine exposure from maternal methamphetamine use was a contributory cause of death. On June 19, 2024, the Department substantiated the allegation of neglect as to Syndi Valdez.

- 3. If the victim in the Preliminary Report involved a child residing in the child's home, the following information will be provided:
  - a. Services being provided to the child, a member of the child's family or the person suspected of the abuse or neglect at the time of the incident and the date of the last contact before the incident between the entity providing services and the person receiving services:

There were no services being provided to the family by the Department of Child Safety at the time of the incident.

b. Was the child, a member of the child's family or the person suspected of the abuse or neglect the subject of a report for investigation at the time of the incident?

c. All involvement of the child's parents and of the person suspected of the abuse or neglect in a situation for which a report for investigation was made or in services provided pursuant to this chapter in the five years preceding the incident:

DCS received the following prior report involving Syndi Valdez:

On October 9, 2018, a report was received alleging neglect to a child by their mother, Syndi Valdez. The allegation was substantiated. The family was initially referred for in-home services with a safety plan in place. Ultimately, the child and siblings were taken into DCS custody and a dependency petition was filed. Ms.

Valdez did not complete reunification services and the parental rights were terminated. The dependency matter was ongoing at the time of the next report.

On April 13, 2020, a report was received alleging neglect to a child by the mother, Syndi Valdez. The child was taken into custody and a dependency petition was filed regarding this child. The allegations were substantiated. Ms. Valdez did not complete reunification services. Parental rights were terminated and the case was closed in November 2021.

d. Any investigation pursuant to a report for investigation concerning the child, a member of the child's family or the person suspected of the abuse or neglect or services provided to the child or the child's family since the date of the incident involving the fatality:

The report regarding the fatality incident was investigated and the case was closed on May 3, 2023. The allegation of neglect to Emmanuel by Ms. Valdez was substantiated. A subsequent report alleging neglect to a newborn sibling was received on November 12, 2023. The child was taken into DCS custody and the Department is providing services to the family.

5. Actions taken by the Department in response to the case including any changes to policy or practice and/or recommendations for further changes in policies, practices, rules or statutes:

The Department conducted a joint investigation with the Maricopa County Sheriff's Office. There were no other children in the home and the case was closed. The allegation of neglect to Emmanuel by Ms. Valdez was substantiated. A subsequent report alleging neglect to a newborn sibling was received on November 12, 2023. The child was taken into DCS custody and the Department is providing services to the family.

Additionally, in accordance with the DCS Strategic Plan for State Fiscal Year 2016 (FY16), multidisciplinary team (MDT) reviews of fatality and near fatality cases were implemented during the first quarter of FY16. The MDT reviews fatality and near fatality cases with prior DCS involvement, which are a key feature of the Strategic Plan and supports the objective of increasing the accuracy of safety and risk assessments in investigations.

Cases are reviewed by the MDT in order to identify any systemic factors, both internal and external to the Department that may have had an impact. The Department uses the aggregate data gathered through all of the MDT reviews to assess and guide future changes and/or recommendations to policies, practices, rules or statutes. Findings from these reviews are compiled into an annual report to be shared on the DCS website. The target date for release of the next report is December 1, 2024.
