**Foster Care at CFC:** In our foster care program we strongly support our foster families in the training and use of parenting interventions from a "trauma-informed" and "attachment-based" perspective. In addition, we are developing a "birth family" mentoring program to assist families of children in DCS care to successfully work their DCS Case Plan in order to be reunified with their children.

**Adoption at CFC:** Certification, extensions and re-certifications for Christian families who are interested in state adoption. All CFC certified families are married more than two (2) years and receive their certification when their youngest child is at least nine (9) months of age. Families must be actively involved in a local church, able to receive a reference from their pastor and successfully complete three education classes beyond those required by the state of Arizona.

Families are provided the professional support of Master's level Christian social workers who share their values and world view, wrap around services during transition and placement, support groups and life time access to outstanding parent education classes.
