**City, town or general location of residence of the child and perpetrator(s):** At the time of the incident, the child and alleged perpetrator(s) were living in Phoenix, Arizona.

**A. Circumstances of the fatality or near fatality that indicate it was the result of abuse or neglect:**

On Oct. 27, 2011, Dani Mayo was taken to the hospital as a trauma case. She was reported to be choking and gasping for air when EMTs arrived at the home. Dani Mayo was found to have old injuries "all over her body," retinal hemorrhage, and her labia was bruised and irritated. Corey R. Daniels reported that Dani was choking on a hot dog, but this was not found to be true. He then stated that Dani got a "whopping." Dani Mayo died as a result of these injuries. Corey Daniels physically abused Dani and is facing murder charges in her death. On Friday, September 20, 2013, Ambreatte Daniels pled guilty to having knowledge of the child abuse involving the death of her daughter, Dani Mayo and failing to protect her.

**B. Whether CPS has received any reports or past cases of child abuse, abandonment or neglect involving the child and the current alleged abusive or neglectful parent, guardian or custodian\* :**

Arizona CPS had no prior reports alleging abuse or neglect of Dani Mayo by Corey R. Daniels or Ambreatte Daniels.

**1. Actions taken by CPS in response to the fatality or near fatality of the child including:**

CPS conducted a joint investigation with the Phoenix Police Department.

**2. Actions taken regarding the child and/or other children in the home:**

There are no other children in the home.

**3. Whether the agency is or intends to provide direct services or service referrals to the family:**

No services were provided.
