Agency Overview

The Arizona Department of Child Safety (the Department or DCS) is the single state administered child welfare services agency for Arizona with an overarching goal to protect children. On February 17, 2015, Governor Douglas A. Ducey appointed Gregory McKay as the new Director. DCS established a mission to successfully engage children and families to ensure safety, strengthen families, and achieve permanency.

Tribal Liaison

The Department created a Tribal Liaison position in 2014 in accordance with Executive Order 2006-14. The Tribal Liaison is responsible for facilitating state-tribal consultation and is tasked with developing, maintaining, and improving communication between DCS and tribes of Arizona. Sharon James-Tiger, DCS Liaison began working for DCS on February 17, 2015 and serves as the single point of contact for the 22 Tribes regarding consultation.

Tribal Government Consultation Policy

The Department is committed to working with American Indian Tribes to improve the quality, availability, and accessibility of human services to children, youth, and adults. The establishment of the Tribal Government Consultation Policy ensures that DCS engages in open, continuous, and meaningful consultation with the 22 Arizona Tribal Nations. The purpose is to provide the forum for information exchange and mutual understanding prior to taking actions that will likely have a direct impact on the American Indian Tribes in Arizona. DCS Tribal Liaison is collaborating with the Tribes to establish the Policy.

Tribal Consultation Activities

The Department continues to honor tribal sovereignty and collaborate with the 22 Tribes of Arizona regarding child welfare programs, policies, and new regulations. The communications are through a variety of mechanisms including the Tribal Consultation Sessions, Inter-Governmental Agreements (IGA), Contracts, and quarterly meetings with the Tribes. The Department has 15 contracts or IGAs with tribes. There are seven contracts for Family Support (FS), Family Preservation (FP), and Family Reunification Services (FRS), four contracts for Specialized Substance Abuse Treatment services, one contract for Comprehensive Service Development, one Title IV-E IGA, one ICWA IGA, and one Consultation contract with the Inter-Tribal Council of Arizona (ITC-A).

The Department held three formal consultation sessions with the Tribes in this report period; December 2014, February 2015, and June 2015. DCS engaged in several collaborative activities with the Tribes during the interim and major collaborative activities are listed in the following table.

Major Accomplishment(s)

The Department works closely with the Tribes to increase compliance with ICWA and provide ICWA training to state and tribal social workers. The Department has a new specialized ICWA Unit located in Phoenix to increase workforce capacity in the area of Indian Child Welfare.

The Department and the Navajo Nation have been engaged in extensive discussions to develop an IGA for coordinating child welfare cases under ICWA. The revised IGA was finalized in December 2014. The Department's Tribal Liaison continues to facilitate quarterly meetings with the Nation's Social Services Department to engage in a dialogue focused on improving outcomes for Navajo children. The quarterly meetings afford the opportunity for a transfer of knowledge and to develop immediate and near term strategies to address mutually identified Indian Child Welfare challenges. The Navajo Nation IGA will serve as a model template for establishing agreements with other Tribes within the state of Arizona.
