## Circumstances of the fatality or near fatality that indicate it was the result of abuse or neglect:

On August 10, 2013, the Department of Child Safety received a report regarding the death of 23-month-old Kristina Prunty. At the time of her death, Kristina was residing in a home with five adults including her mother, Kari "Amber" Swaim; her mother's boyfriend, Jagger Hunt; her maternal aunt, Stacy Gledhill, her aunt's boyfriend, Brandon Morgan; and Sandie Hunt, mother to Jagger Hunter and Brandon Morgan. Ms. Swaim reported that she put Kristina to bed the night of August 9, 2013 at 10:00pm and found her to be cold to the touch when checked on the following morning around 5:30am. The family called 911and Kristina was transported by ambulance to the hospital where she was found to be dead on arrival.

Upon examination, Kristina was found to have significant injuries which included numerous bruises in varying stages of healing to her face, arms, legs, back, buttocks, pelvic area, stomach and foot; bite marks to her shoulder, knee and left cheek and abrasions on the crown of her head, nose and lip. An autopsy was later performed revealing massive internal injuries which included skull fractures on the right and left sides of her head; a severed liver and a severed pancreas. The injuries were diagnosed as non-accidental trauma and resulted in Kristina's death. An autopsy was performed by the Maricopa Medical Examiner's Office and determined the cause of death as multiple blunt force trauma and the manner of death as homicide.

DCS has received no prior report(s) alleging abuse or neglect of Kristina Prunty by Kari "Amber" Swaim, Jagger Hunt, Sandie Hunt, Stacy Gledhill or Brandon Morgan.
