7. Circumstances of the near fatality that indicate it was the result of abuse or neglect:

On July 13, 2015, the Department of Child Safety received a report alleging neglect to the child by Valare Peralta. The child was involved in a three car accident in which mother was driving. The child's mother, Valare Peralta and sibling passed away at the scene. There was methamphetamine drug paraphernalia found in the vehicle. The child had the following injuries: bilateral pulmonary contusion (lungs), right pneumothorax, left temporal skull fracture, cardiac contusion, liver laceration, bilateral lateral epicondyle fracture, and hypoxemia and was in respiratory distress. It was determined that the child was not properly restrained. In addition, it was determined that Valare Peralta had significant amounts of methamphetamine in her system while driving the vehicle. The allegation has been substantiated.

8. Whether DCS has received any reports or past cases, of child abuse, abandonment or neglect involving the child or the current alleged perpetrator(s):

DCS has received two prior reports involving mother, Valare Peralta, and two siblings.

On July 5, 2009, a report was received alleging neglect to a sibling by mother, Valare Peralta. The investigation assessed the child as safe. The family set up a guardianship of the sibling with a family member. Community resources were provided to the family. The allegation was unsubstantiated and the case was closed on September 1, 2009.

On February 24, 2014, a report was received alleging neglect to a sibling by mother, Valare Peralta. The investigation assessed the sibling to be safe. The family was offered services by the Department, but declined. The allegation was unsubstantiated and the case was closed on June 6, 2014.

9. Actions taken by DCS in response to the near fatality:

A joint investigation is being conducted with the Arizona Department of Public Safety.

10. Actions taken regarding the child and/or other children in the home:

The child was released from the hospital and is residing with a relative.

11. Whether the agency is or intends to provide direct services or service referrals to the family:
