Dear VFC Provider,

As of December 15, 2015 the **Arizona VFC program is out of Fluzone® 1-dose 0.5mL syringes**. In addition, **Arizona VFC is almost out of FluLaval® 5.0 mL 10-dose vials**. The table below lists the influenza vaccine presentations (all quadrivalent) still available for AZ VFC providers to order through ASIIS:

Please continue to place orders as needed for influenza vaccines. As always, prior to placing a vaccine order, temperature logs must be submitted to the Vaccine Center up to the day before the order is placed, and current VFC vaccine inventory must be reconciled in ASIIS.

As VFC inventory of influenza vaccines decreases the AZ Vaccine Center might need to implement the Arizona VFC Vaccine Choice Policy. This policy states that the AZ Vaccine Center will make every attempt to honor provider vaccine choice, but if a brand chosen by the provider is not available, AZ Vaccine Center staff may ship an alternative (but equivalent) vaccine. If no equivalent is available AZ Vaccine Center staff will contact your office. Please review the attached document for a more detailed description of the policy.
